## Appreciated investment and security assets

### Qualified charitable donation (gift from an IRA)

Did you know that a qualified charitable distribution may be made:

- When the IRA holder is 70 ½ or older
- Directly from the IRA to a qualified charity
- From a traditional or Roth IRA

A qualified charitable distribution can be used to satisfy required minimum distributions from an IRA without having the distribution included in their income.

### Gifts of real estate (land, property, home or farm) help support Missouri Delta Medical Center and can provide tax benefits.

**Planned Giving** - Planned giving allows the potential to increase the size of your estate and/or decrease the tax burden on your beneficiaries. Please contact your attorney, accountant or advisor to assist with the financial advantages unique to your situation.

**Bequests or Wills** - Individuals can make a special gift by naming Missouri Delta Medical Center in a will, also known as a bequest. Bequests of cash, securities, real estate or personal property (art or jewelry) can be designated as unrestricted or directed to a special area. A bequest can also provide tax estate benefits.

**Life Insurance** - Individuals can designate Missouri Delta Medical Center as the beneficiary to a life insurance policy that may no longer be needed for its original purpose.

**Savings Accounts and Certificate of Deposits** - Funds in saving accounts and certificates of deposits can support Missouri Delta Medical Center if the hospital is a joint owner of the account with rights of survivorship only. Consult with an attorney or financial planner who is knowledgeable about estate planning and familiar with the laws in the state where you live.

## AVAILABLE FUNDS INCLUDE THE FOLLOWING:

### NEWLY OPENED ADOLESCENT BEHAVIORAL HEALTH UNIT

This 15 bed unit opened May 2020 and serves adolescents 12-17 with suicidal ideations, behavioral disorders, depression and anxiety just to name a few. The unit has served over 200 adolescents as of May 2020. The adolescents seen in our clinic are from all over the state of Missouri.

### GENERAL FUND

The money in the general fund allows us to purchase or partially fund items for the hospital that increase the quality of care for our patients. One item that Missouri Delta has recently purchased is the Mako SmartRobotics™ for total knee replacements. The Foundation committed \$95,000 towards this new robot. "This is a game changer for Southeast Missouri," says Dr. Rudy Rodriguez, Orthopedic Surgeon.

### MAMMOGRAPHY FUND

The money donated to the mammography fund allows Missouri Delta to help the underinsured and un-insured patients receive a screening mammogram. Since its inception in 2011, the Breast Cancer Awareness Luncheon has raised thousands of dollars to go toward many breast health initiatives at Missouri Delta, such as a 3D mammography unit, stereotactic addition to 3D mammography unit for biopsies, smart curve paddles, updated software and plush robes for patient comfort.

### ENDOWMENT FUND

The endowment fund is security for the Foundation as well as Missouri Delta Medical Center. This fund allows us to keep the principal amount intact while using the investment income for help with capital purchases.

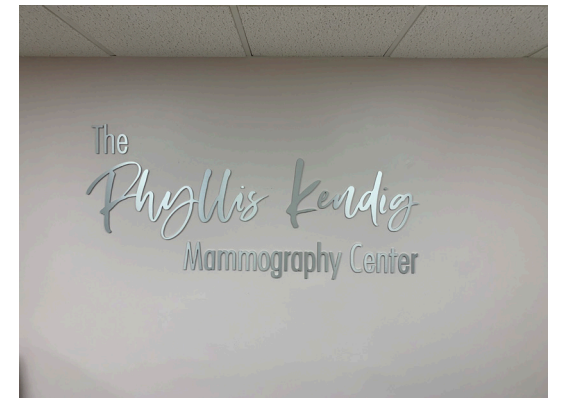

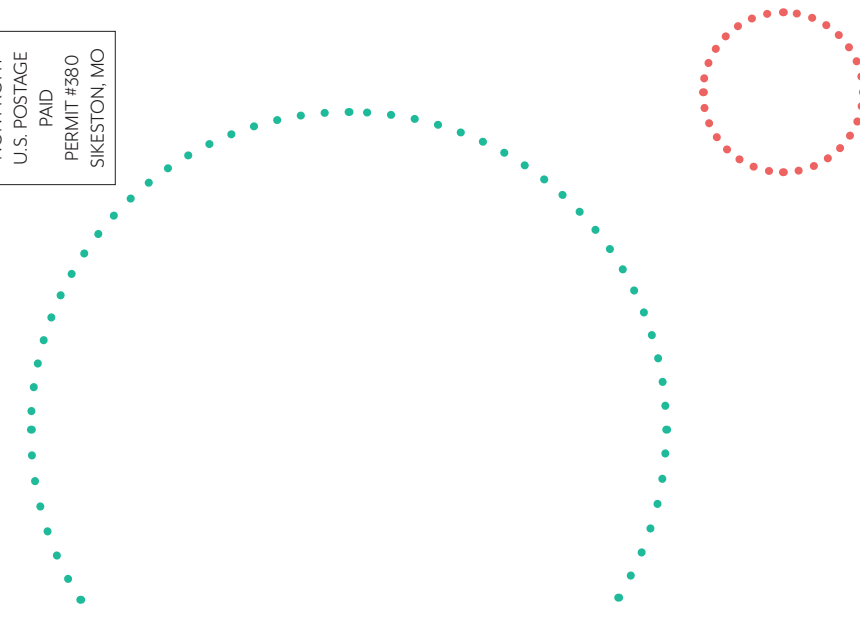
