## A Letter from the President + CEO

# Jason Schrumpf, President + CEO

### Growing through Connectivity

The success of a community hospital is largely dependent on its connectivity with its employees, providers, patients, and the communities it supports. It is the connectivity with our workforce that has helped us reduce the number of travelers used this past year and enhance employee and provider retention rates. Our connections with all the clinical training programs in our region have helped improve our new graduate recruitment success. Connecting with patients, who entrust us with their health and wellness, has resulted in record clinic visits and revenue. Connectivity with employers and business community helped create pathways to keep healthcare local for their workforce. With the many headwinds in the healthcare landscape, these connections are vital to our sustainability.

This connectiveness has played a major role with our strong operational statistics and quality scores in 2023. We experienced a 5-year high with 455 births and 1,244 endoscopy cases and all-time record highs with 172,829 clinic visits, 442,017 laboratory tests, 51,515 radiology exams and 111,047 therapy visits. Most importantly, our patient safety domain clinical quality scores finished in the top 10% of Missouri hospitals.

From a financial perspective, we experienced a tremendous turnaround in 2023 with a positive 5.6% net income. Strong outpatient volume and growth of pharmacy related revenues combined with less bad debt deductions resulted in record

net revenues of \$146,868,398. On the expense side, outsourced purchased services expense was cut by over \$2.6 million, largely due to less use of travel staff and elimination of inpatient behavioral health management services. We focused our efforts on retaining our workforce by ensuring a supportive work environment through safe patient to staff ratios.

I am very proud of the growth we have experienced this past year and excited about our future opportunities. This growth would not be possible without the generous support and connectivity of our community. On behalf of our Board of Directors, Foundation and entire workforce, we would like to express our deep appreciation for your past and future partnership.

Thank you for taking time to connect with us through our 2023 Annual Report. Throughout this report, you will find stories of inspiration, and highlights of new technology and service lines, updated medical equipment, new physicians and providers, facility expansion and renovations, innovative care delivery programs and future growth plans that will help further connect you with our community hospital.

### Strategic Integration of LPNs: Mitigating Inpatient Staffing Crisis

Missouri Delta has taken a proactive approach in addressing a critical staffing shortage that has plagued hospitals across the U.S. Aligning our mission and values with quality patient care, Missouri Delta has strategically incorporated Licensed Practical Nurses (LPNs) into its healthcare team, allowing them to work at the top of their licensure. "Our key objective in this initiative was to alleviate staffing strain in the hospital and also ensure delivery of high-quality care to patients consistently," explains Sam Stephenson, RN, nurse manager. "After analyzing the LPN integration, we saw a considerable decrease in unfilled shifts and an upward trend in patient satisfaction scores". The incorporation of LPNs as a strategic solution to the staffing crisis demonstrates Missouri Delta's innovation and adaptability in consistent, high-quality care.

## Gift Shop & Auxiliary

The Missouri Delta Auxiliary consists of dedicated men and women who freely volunteer their time to help others. # A Word from Foundation **President**

**Ann W. Matthews- President 2023**

It has been an honor and a privilege to serve on the MDMC Foundation Board for the past six years. As in years past, the Foundation has been able to provide assistance to the hospital this year by purchasing equipment, assistance with a capital campaign, and providing scholarship funds to employees. This is made possible because of the generosity of individuals of this community and the surrounding areas, plus businesses, endowments and organizations who all believe in the importance of quality medical care here in Sikeston.

This year saw the opening of the Lawrence Family Medical Building that provides physical and occupational therapy services, along with housing podiatry and occupational medicine departments. The Foundation contributed \$500,000 this year toward the building, in addition to the lead gift from the Lawrence family.

Foundation funds have been utilized to enhance services in several areas. These include upgrades to fluoroscopy technology in radiology, a state-of-the-art bone density machine, diagnostic equipment for the newly-established vestibular audiology area, chairs for infusion patients at the infusion center and additional equipment for the Emergency Department.

In November the Missouri Delta Benefit Ball was held, raising an additional \$103,000 earmarked for the Lawrence Family Medical Building.

The trustees of the Foundation along with administration and employees thank you, the donors, for your continued support. It is only because of your generosity that the Foundation is able to further its mission to “assist, advance and strengthen Missouri Delta Medical Center in its mission of healing.”

# Advancing Diagnostic Imaging

## Newest Technology in Bone Health

Bone densitometry, also called DEXA or DXA, uses a very small dose of ionizing radiation to produce pictures of the inside of the body to measure bone loss. It is commonly used to diagnose osteoporosis and the risk for developing fragility fractures.

And now, with the help of the Foundation, Missouri Delta Endocrine and Diabetes Center has the newest DEXA technology, the GE Healthcare Prodigy with updated software. This bone density test is a low-dose x-ray machine that is attached to a computer and can quantify how dense the bone is, while the software gives further clarification on bone health.

“Over 20 years ago, Missouri Delta Endocrine and Diabetes Center began evaluating, diagnosing, and treating metabolic bone disorders. This newest technology shows our dedication to bone health and its importance,” explains Dr. Muhannad Al-Kilani, Endocrinologist/Diabetologist. “Osteoporosis related hip or vertebral fractures can increase mortality and/or potential disability.

### Who is at increased risk of osteoporosis?

- menopausal woman
- over 70 years of age
- younger persons if exposed to repeated prednisone/ corticosteroid treatment
- those with chronic rheumatoid arthritis and related illnesses
- those with significant eating disorders in childhood
- those with chronic parathyroid disorder
- post-transplant patients

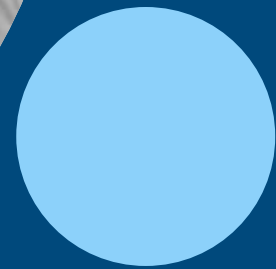
A primary care provider may choose to order a bone density evaluation for patients with other potential calcium or phosphorus disorders.

Dr. Al-Kilani has maintained continuous and updated education, with repeated certifications by the International Society of Clinical Densitometry for evaluating, diagnosing, and managing osteoporosis.

## Emergency Department SiteRite™ 9 Ultrasound System

### Improving Clinician Efficiency

Missouri Delta Foundation purchased a SiteRite™ 9 Ultrasound System for the Emergency Department in 2023. This new technology is designed to help improve clinician efficiency and aids in first attempt insertion success rate with placing IV lines, and other vascular access devices. The Ultrasound System is equipped with a larger screen size (15.6-inch touch screen) and enhanced imaging quality. According to Chris Hawkins, Emergency Department Director, "A couple of patients have actually hugged me because they are normally a 'hard stick', and this technology kept them from being stuck repeatedly."



# Recognition & Innovations



## Health Equity Award

Missouri Delta Medical Center has been awarded the 2023 Health Equity Award by Health Quality Innovator (HQI) for the creation of the Missouri Delta Patient Food Pantry which opened in February last year. The Health Equity award category recognizes organizations that have successfully implemented interventions and approaches to address disparities across a range of conditions and improve healthcare quality and outcomes. Since the inception of the pantry, 351 patients were discharged from Missouri Delta with a large bag of food and a referral to the SEMO Food Bank, who in turn connects the patients to resources such as senior food boxes, SNAP benefits, info on local food pantries and more. The Foundation, with huge support from the VFW Post 3174 in Sikeston, keeps the Patient Food Pantry stocked and ready with needed items.



## HCAHPS Improvements

Missouri Delta Medical Center had a total of 325 Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) surveys returned for 2023. Compared to 2022, with a total of 360 surveys returned, Missouri Delta has had significant HCAHPS improvements reported in all 8 categories. We continuously look for new ways to increase patient satisfaction scores as efficiently and effectively as possible.



### Speciality Pharmacy

Missouri Delta has added “Specialty” Pharmacy to our services and is the first of its kind in Sikeston and the surrounding area. Specialty Pharmacy is a niche branch of pharmaceutical care dedicated to complex, high-cost medications that often require special handling, administration, or monitoring. It goes beyond the scope of traditional pharmacies by focusing on medications for chronic and rare conditions like cancer, HIV/AIDS, multiple sclerosis, and others. The new Specialty Pharmacy at Missouri Delta launched in December 2023, providing comprehensive support via a new software system, TherigySTM, including personalized medication management, patient education, coordination with healthcare providers and insurance assistance.



### Ion Robot

We are pleased to have added the Ion Endoluminal System to our existing robot technology. The Ion Robot enables physicians to biopsy lung nodules and masses deep within the lung... with improved accuracy and fewer side effects. With the Ion working alongside the Linear EBUS (Endobronchial Ultrasound), patients are diagnosed with one procedure and referred to the appropriate treating physician quicker. Since June 2023, 30 procedures have been completed with 16 having a cancer diagnosis.



# Partnership and Outreach 2023



## Phlebotomy Class | Sikeston Public Schools

The Sikeston Public School Health Occupations Instructor and Certified Nurse Assistant (CNA) Examiner had 8 of her CNA graduates participate in 30 hours of clinical rotations in laboratories across Missouri Delta locations, such as Smith Street Clinic, Women's Care Center, Primary Care and of course the medical center. Each graduate completed 30 venous and 10 capillary punctures. After completion of the class, the participants were eligible to take the National Healthcareer Association (NHA) certification exam, though it is not required for employment. One student has already joined the Missouri Delta lab team and plans to start nursing school soon.



## Workforce Opportunity Grant | Southeast College of Nursing & Health Sciences

Missouri Delta began participating in the Rural Healthcare Training and Retaining Initiative in 2023 with Southeast College of Nursing & Health Sciences. The program is designed to alleviate healthcare worker shortages by creating sustainable employment and training programs. The training prepares workers for entry into a healthcare occupation and will be held at Missouri Delta. Ten students will participate in each session which includes 6 weeks of classroom education and 1 week of patient care clinical training on the inpatient units. Instructors, course material and grant-funded equipment are provided by Southeast and Missouri Delta employs students as techs, provides the classroom and remainder of equipment needed for use during the program.



## Nurse Residency Program

A Nurse Residency Program was established at Missouri Delta in the Fall of 2023. Nurses in their first year of employment at Missouri Delta are enrolled in a 4-month educational program which includes lectures and hands-on activities, meeting once each month. Directors and Managers from departments such as Infection Control, Pharmacy, Laboratory, Critical Care, and Respiratory are involved as well as product representatives for skin, wound and colostomy care. The environment is designed to be a low stress environment with questions and input encouraged.



## Phlebotomy | New Madrid County High School Technical Skills Center – Phlebotomy Course

Missouri Delta Lab Director, Margot Hart, recently provided a hands-on education session with students from the New Madrid County High School Technical Skills Center. Students were able to prepare peripheral smear slides of their own blood and review on the microscope, run kit tests, and discuss the testing performed in the different areas of the lab. Students from the New Madrid Center also attended clinicals at the Missouri Delta main laboratory and several clinics within the Missouri Delta system.



## National Guard Medical Training

In June 2023, 35 Air National Guard members performed clinical rotations at Missouri Delta Medical Center to fulfill clinical practice requirements under the National Guard Bureau's Innovative Readiness Training (IRT) program. Members were assigned to the Emergency Department and the Intensive Care Unit (ICU) over the course of 10 days. The Guardsmen consisted of medical technicians, nurses, and physician assistants, each completing 40 acute care hours.

## Breast Cancer Awareness Event



The 2023 Breast Cancer Luncheon took place on Friday, October 6, at the First Christian Church in Sikeston. The luncheon included a guest speaker, Lesley Miller, lunch, and special recognition for breast cancer survivors who have fought battles against cancer. Lesley Miller, this year's speaker, was diagnosed with invasive ductal carcinoma, or IDC, at the age of 40.

Miller said her life was perfect just before discovering her cancer. She had completed her 12-year teaching degree in order to stay at home and homeschool her children, expecting that this would allow them more time to travel.

"My then, 8-month-old son stopped nursing on my right side," Miller said. "At first, I didn't think too much about it," Miller said. While taking a bath one night, she felt two lumps under her armpits. Miller went ahead and made an appointment because she believed God was telling her to do so and she was soon undergoing an ultrasound and biopsy.

Miller said she clung to her faith and God's word during this difficult time of many unknowns. IDC is the most common type of breast cancer, and Alcorn said she hoped Miller's testimony at the luncheon motivated more women to speak up for themselves when something doesn't feel right.

The funds raised are used to provide the newest training to Missouri Delta Medical Center's mammography technicians and radiologists. "Breast cancer awareness is important because one in eight women will be diagnosed with breast cancer," Alcorn said. "Breast cancer is one of the most treatable cancers if caught early; that's why the recommendation is to have your baseline mammogram between the ages of 35-40 unless you have a strong family history; then you should have one earlier."
