## The CuddleCot™

Stillbirth and infant loss are not easy to talk about, but for many parents and families, it's their reality. A couple from Ohio, Erin and Anthony Maroon, lost their child Ashlie when she was stillborn at full term. They could not keep her at room temperature because of the natural changes that occur after death, but the freezing temperatures of the hospital's cold room were changing her small features too quickly. After less than an hour with her and still in shock over their loss, they said goodbye to their baby girl forever. Determined to change things for future families, the Maroons founded Ashlie's Embrace, a 501(c)(3) non-profit organization, dedicated to providing CuddleCots™ to US medical centers so parents have more time to hold their baby and say goodbye. Ashlie's Embrace was gracious and provided Missouri Delta Women's & Children's Center with a CuddleCot™. The CuddleCot™ system cools the baby insitu, allowing the baby to remain with the family. The cooling pad is placed in any Moses basket, crib, pram or bed. It is connected by a specially insulated hose and is quietly cooled using the special cooling unit. Thanks to Ashlie's Embrace, Missouri Delta is now able to provide bereaved parents with the option of spending up to 96 hours with their precious baby. As of the beginning of 2023, Ashlie's Embrace has placed 193 CuddleCots™ in 50 states.

## LATEST UPDATES

This year Missouri Delta will add, and continue to add, many new services for our patients and community members.



### LAWRENCE FAMILY MEDICAL BUILDING

To meet the needs of our growing services and additional medical professionals, Missouri Delta is constructing a new 23,189 square foot facility to house ReStart, Occupational Medicine and Podiatry. In 2022, ReStart alone had over 28,000 therapy appointments. Occupational Medicine now services over 200 employers in the region; offering injury assessment, DOT physicals, drug and alcohol testing, immunization programs, health fairs and an efficient after hours on-call service. Occ Med is currently sharing space with ENT, Allergy and Vestibular Rehab services. Our new service line, Podiatry, will also be moving to the new building. Jacob Randich, DPM, and his team provide treatment to keep people active and on their feet. Dr. Randich treats conditions such as tendinitis, deformities leading to pain, calluses, arthritis, sprains and fractures. Podiatry is also important for diabetics in preventing ulceration and amputation.



### COST-CUTTING MEASURES

When our growing expenses and input costs exceeded revenue, we took a series of cost-cutting steps to balance our budget. Highlights of the deficit reduction plan largely consisted of workforce optimization through less reliance on contract labor and elimination of the travel at home program. We also took steps to consolidate our management structure and eliminate our Homemaker service line. On January 1, Missouri Delta took over management of the Inpatient Rehabilitation Unit from Horizon Health. This transition has been successful with improved operations, better collaboration with hospital support staff and savings exceeding \$150,000/year. Subsequently, we also ended our management agreement with Horizon Health for our adolescent and geriatric behavioral health units on December 31, 2022. We will not only employ the management staff but also the two Psychiatrists.



### KEEPING THE FUTURE OF HEALTHCARE GROWING

Missouri Delta touches the lives of our patients in many ways. We help educate and train our clinical workforce by offering clinical sites for local high schools and all the major educational programs in our region. To keep the future of healthcare growing, Missouri Delta has partnered with the Sikeston Regional Chamber with their SOAR program (Students Observing Area Resources). This engaging program was developed specifically for the SCTC (Sikeston Career & Technology Center) students so they become aware of potential career opportunities Sikeston has to offer. On their “Healthcare Day”, students tour our facility and participate in hands-on experiences to initiate the idea of pursuing a career in healthcare. Missouri Delta provides preceptorships for first and third year medical students from University of MO-Columbia, University of MO-Kansas City and Kirksville College of Osteopathic Medicine. We also offer a variety of educational classes such as CPR, neonatal resuscitation, basic arrhythmia, advanced cardiac life support and pediatric advanced life support to our employees and other healthcare providers in our region.



### PATIENT PANTRY

February 1, 2023, we launched our Patient Pantry. Missouri Delta patients will be screened to determine food insecurity issues. Those who are identified will receive approximately 20 pounds of healthy food to take home with them upon discharge. More importantly, individuals will be connected to other food assistance services the food bank provides, such as access to food pantries, enrollment for a monthly senior food box or help applying for Supplemental Nutrition Assistance Program (SNAP) benefits. The Joint Commission released a new requirement for 2023 which involves reducing healthcare disparities. Food Insecurity is the social need Missouri Delta has chosen to address for the year 2023. Our patient pantry will fulfill this standard while also assisting our patients.

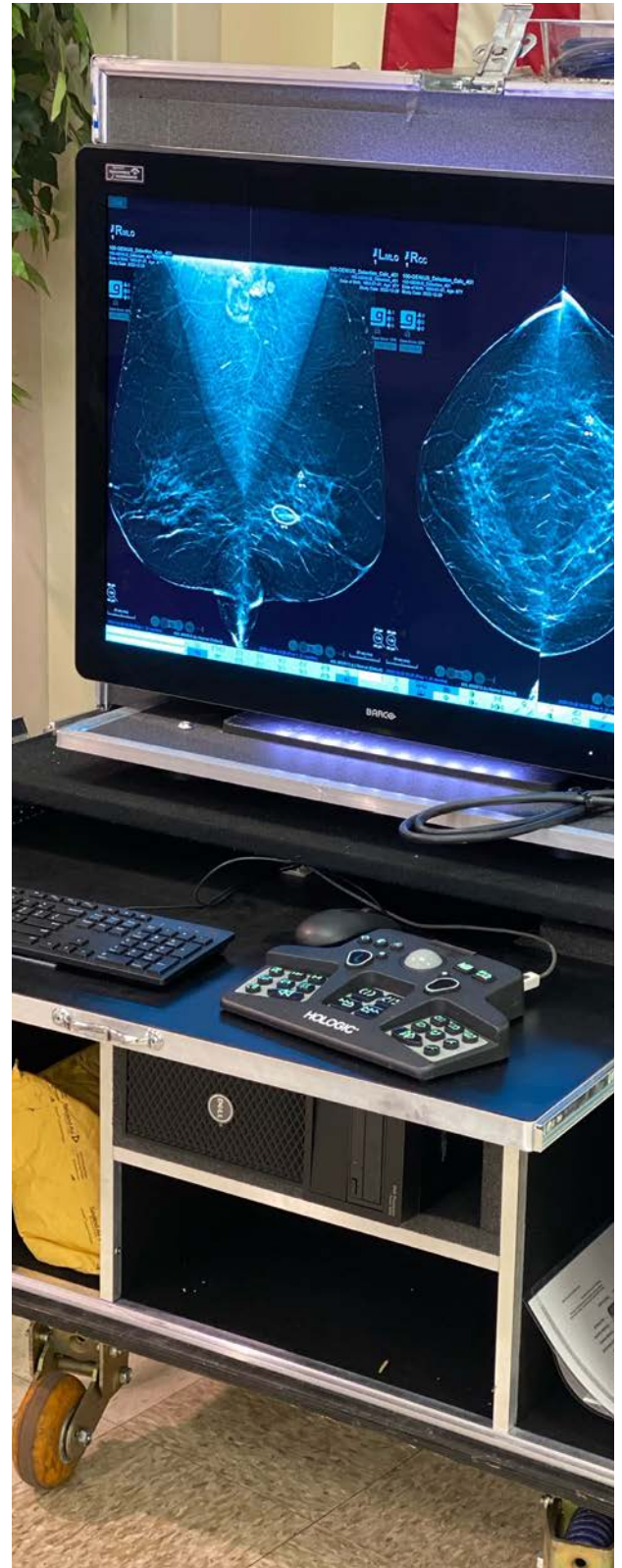

This funding has made it possible for not only the growth and expansion of the hospital but elevated the quality of healthcare provided to the community. Providing exceptional obstetric care is indispensable in our surrounding region. This historic achievement would not be possible without the steadfast support of the Missouri Delta's devoted patrons and the generosity of the O'Bannon family farm proceeds for a grand total of \$6,353,576.60.

In addition to completion of the bond, your contributions have ushered in a grand total of \$512,884.00 towards the Missouri Delta Medical Center needs. Your substantial monetary gifts provide new state of the art equipment, advance educational status, continued growth of hospital needs, and bestow crucial funding for patients and employees.

Your support and contributions of 2022 have allowed Missouri Delta Medical Center to continue expanding vital healthcare services which are core to Sikeston and the regional area. The Foundation's donations come from city organizations, local businesses, families, and individuals. This broad-based support has enabled Missouri Delta Medical Center to maintain its vitality as a community hospital while expanding the healthcare services it is able to provide to its patients.

The cutting-edge Hologic 3-D Mammography Machine was complimented with the purchase of the iCAD in 2021. This artificial intelligence software equipment is a global medical technology and developed by iCAD. It is a leader, providing innovative cancer detection and therapy solutions. This technology provides precise, powerful healthcare solutions expertly engineered to optimize operational efficiency, clinician confidence, and patient outcomes. This new state of the art equipment brings our rural hospital treatment and testing capabilities to the highest medical standards across the board. Missouri Delta is the only medical center in the region that provides the highest resolution technology available on the market.

Another accomplishment of 2022 was the charitable contributions you provided in collaboration with the Lion's Club International Grant for the purchase of the Endobronchial Ultrasound (EBUS) for the Pulmonology department. The technology of the new Olympus EBUS offers a comprehensive solution for diagnosing and staging lung cancer performed in real time. The pulmonologist can easily navigate the equipment that allows increased precision, even in the most difficult-to-reach lymph nodes and lesions. This equipment is crucial, especially for treating our local region which has one of the highest rates of lung cancer in the United States. Specialized services such as these would

simply not be possible at our hospital without your steadfast support and financial commitments.

Furthermore, the Foundation is excited to welcome the construction and expansion of outpatient services to be completed in the summer of 2023 —The new Lawrence Family Medical Building. The new development will house ReStart, Occupational Medicine, and Podiatry. Podiatry is a new service to Missouri Delta and we are excited to be able to provide these services to our patients. The new building will be 23,189 square feet and house approximately 30 employees. This is yet another shining example of the continued progress that Missouri Delta patrons have supported for the continued growth of medical services provided to our community.

Lastly, even though this year has just begun, preparations are underway for the long-standing tradition of hosting the Missouri Delta Hospital Ball. Throughout the years, the Foundation's Benefit Ball has been able to raise monies by the endorsement of the community citizens and local businesses. These donations are applied back to the needs of Missouri Delta Medical Center. Investing into our medical center is fundamental in delivering high quality healthcare services to our local area. Please know that your contributions have and will continue to improve countless lives in our community.

## Medicare Accountable Care Organization AMY THOMPSON, RN, POPLUATION HEALTH MANAGER

Missouri Delta Medical Center continues to be a member of a Medicare Accountable Care Organization (ACO) – Signify Health. We currently have 2,769 assigned lives that we ensure get the right care at the right time, and at the right place. All while avoiding unnecessary duplication of services and preventing medical errors. The ACO provides Missouri Delta an opportunity to participate in the Medicare Shared Savings program where we can earn additional funds by providing high quality care and decreasing cost to the patients through value-based care. This is accomplished by helping patients manage chronic illness, promoting wellness, with an emphasis on preventative care by completing annual wellness visits, and care management services. In 2021, Missouri Delta received \$375,808 in shared savings.

Our Patient Centered Health Home (PCHH) continues to grow. This program is funded by the state of Missouri and Missouri Delta has participated in it for several years. Patients with Medicaid coverage and who meet certain criteria, are eligible to enroll in our PCHH. The criteria consists of meeting two or more chronic health conditions including asthma/COPD, developmental disabilities, diabetes, heart disease, obesity, and tobacco use. We currently have 10 clinics as part of our PCHH and 9 of them have earned recognition from the National Committee for Quality Assurance (NCQA). The 10th clinic should reach NCQA recognition this year. We currently have 1,195 patients enrolled in our PCHH, which focuses on preventative care and wellness management. Our health care team works closely with these patients to improve their quality of life and educate them how to better manage their medical conditions. We receive approximately \$70,000 monthly from the State of Missouri to care for the patients enrolled in our NCQA.



## Vestibular Audiology

In August 2022, Missouri Delta introduced a new service: Missouri Delta ReBalance and Dizziness Center. This center is a collaboration between our vestibular audiologist, Zach Shaw, AuD, CCC-A and physical therapist, Chance White, DPT. Together they evaluate and create a treatment plan for patients with vertigo, dizziness, mobility issues and balance disorders. **Missouri Delta ReBalance and Dizziness Center is one of only 2 clinics in the state of Missouri that offers both Vestibular Specialized Audiology and Vestibular Therapy.**

Missouri Delta Foundation contributed the funds for the vestibular testing equipment. Dr. Shaw uses the new equipment to perform a comprehensive evaluation with data interpretation and combines test findings with current evidence-based research, experience, and expertise. "There is a vital role of inner ear function in academic performance of children. Helping to identify these deficits is simple and could change a child's life for the better. Vestibular and balance disorders are very treatable and beatable for people of all ages," stated Shaw.

# STROKE

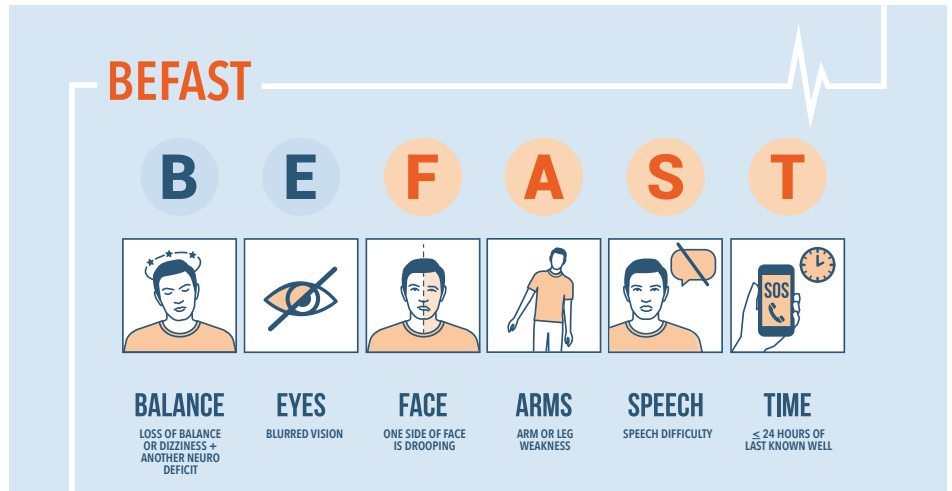
## 3-YEAR STROKE CENTER

Throughout the past two years, Missouri Delta has been providing additional training, education, updating policies and procedures to make the necessary stroke care enhancements to be designated a level III stroke center in the state's Time Critical Diagnosis (TCD) system. We are excited to announce that on October 29th, 2022, we received a 3-year stroke center designation by the state.

The Time Critical Diagnosis (TCD) system, created in 2013 through the Missouri Department of Health and Human Services, is a statewide emergency medical care response system aimed at providing a quicker response and higher quality care when a time critical emergency such as stroke happens. The goal of the TCD system is to create consistent, statewide rules and regulations to help EMS, EMTs and hospital personnel ensure patients are being transported to and treated by the most appropriate facility for their needs.

"A stroke is a time critical medical emergency requiring a rapid assessment, diagnosis and treatment," says Chris Hawkins, Missouri Delta Emergency Department Director. "Patients must receive care within the shortest amount of time to minimize injury to the brain to improve prognosis."

The TCD system implements four levels of hospital designation across the state, with Level I considered the highest based on services offered. Once a hospital completes the rigorous process to become a designated stroke center, hospitals are then required to meet strict state guidelines and



undergo a rigorous survey in another three years. While the decision to apply for a stroke center designation is a voluntary one, the achievement speaks volumes about the dedication Missouri Delta employees have to provide our patients the absolute best care and outcome.

**B.E.F.A.S.T.** is an easy way to remember the sudden signs of a stroke.

**B • BALANCE** | Loss of balance or dizziness and another neuro deficit. Is the person suddenly having trouble with balance or coordination?

**E • EYES** | Blurred vision. Is the person experiencing suddenly blurred or double vision in one or both eyes without pain?

**F • FACE DROPPING** | Does one side of the face droop or is it numb? Ask the person to smile.

**A • ARM WEAKNESS** | Is one arm weak or numb? Ask the person to raise both arms. Does one arm drift downward?

**S • SPEECH DIFFICULTY** | Is speech slurred, are they unable to speak, or are they hard to understand? Ask the person to repeat a simple sentence, like "the sky is blue." Is the sentence repeated correctly?

**T • TIME TO CALL 9-1-1** | If the person shows any of these symptoms, even if the symptoms go away, call 9-1-1 and get them to the hospital immediately.

## OTHER SYMPTOMS TO NOTE

- Sudden numbness or weakness of the leg.
- Sudden confusion or trouble understanding.
- Sudden trouble seeing in one or both eyes.
- Sudden trouble walking, dizziness, loss of balance or coordination.
- Sudden severe headache with no known cause.

### Mark Sever Award - Allie Eftink, RN

The Mark Sever Award was put into motion to recognize a deserving individual that exemplifies the characteristics of excellence. The Mark Sever Award recognizes an Emergency Department colleague. Mark Sever, DO, worked with Missouri Delta for 17 years in the Emergency Department. This award was established in memory and appreciation of him and his foundation work in the development of our emergency services.

Allie Eftink, RN, received the Mark Sever Award for 2022. She is described by co-workers in the Emergency Department as *“a nurse that is professional, has a great attitude and is always positive. She has sound integrity and always does the right thing.”* Allie has been known to work extra shifts to help the Emergency Department, supporting her teammates so they have enough help. “Allie cares about her patients and doesn’t rest until her patients get what they need. She is always smiling and helpful, even in the most stressful times.” Allie has been a nurse at Missouri Delta for 8 years and in the Emergency Department specifically since May 2019.

### Manager of the Year - Christi Hubbard, RN, Surgical Services

The Manager of the Year award is given by administration to a person for their outstanding contributions to leadership and their department during the past year.

Christi Hubbard, RN, started at Missouri Delta in May of 2008 as a surgery technician and became a Registered Nurse in July of 2012. After experiencing much success in both of her previous roles, she received the Directorship of Surgical Services position in July of 2016. Under her leadership this past year, there were 3,336 surgical and 1,211 endoscopy cases performed. *“She is a team player and always willing to help....known to fill in as a surgery technician or nurse circulator, man the surgery desk, courier supplies from other locations, and even taking shifts on call. She is calm under pressure and serves as an excellent liaison between staff and surgeons.”* Members of her department describe her as very hands-on, hard-working, conscientious, approachable, and knowledgeable.



# JASON SCHRUMPF, PRESIDENT + CEO REFLECTS ON THE YEAR

## BUILDING STABILITY IN UNSTABLE TIMES

Rural healthcare is the lifeline for any prosperous community. Hospitals and clinics are critically important to address the health and healthcare needs of patients and families who live in rural communities. From emergency medical and acute care to managing chronic conditions and providing access to the best specialists, rural healthcare services are vitally important.

Our healthcare system, like others around the nation, faced significant financial pressures, from historic inflation, rising pharmaceutical and labor costs, COVID-19 expiration of CARES Act funding, and reimbursement not keeping pace with rising expenses. Throughout the year, our workforce operated under tremendous strain with fatigue and frustration experienced at times. Despite these headwinds, we continued to deliver compassionate, quality care as we still managed to grow and execute our strategic plan.

January 2022 started off with the Omicron COVID surge resulting in 104 patients treated, the highest number of monthly COVID admissions on record. As the COVID numbers trended down to manageable levels, staffing shortages persisted, forcing continued reliance on expensive contract labor and travel-at-home programs. Unfortunately, the rising expenses outpaced a stagnant reimbursement environment, making for a very challenging year. In most industries, the business can pass along input cost increases to the consumer. In healthcare, this is virtually impossible since most of our reimbursement is fixed by our government and commercial payers.

Missouri Delta Medical Center is committed to improving quality and safety of our patients. In 2022, our patients did not experience any central line associated blood stream infections or catheter associated urinary tract infections, despite the national average rising 5-7 percent across all hospitals in the U.S. These infection control and safety scores place Missouri Delta Medical Center in the top 15% of hospitals nationally.

I want to take a moment to recognize and reflect on the healthcare services and the number of lives Missouri Delta impacted in 2022. This past year, we cared for over 4,035 patients in our hospital; treated over 19,800 patients in our Emergency Room; performed 3,335 surgeries and 1,211 endoscopies; processed 389,665 lab tests; completed 47,073 radiology exams; provided 106,802 therapy treatments; completed 171,486 clinic visits and helped bring 450 babies into this world.

Despite experiencing lower inpatient admissions partly attributed to labor shortage capacity constraints, we saw growth in deliveries, surgery cases, emergency room visits, therapy treatments and outpatient clinic visits hit a record of 171,345, a 10% increase over 2021. Gross revenues grew to a record high of over \$473 million with a continued trend favoring outpatient to inpatient volume. It is evident through these statistics that Missouri Delta is on solid footing with steady volumes and revenue.

### MISSOURI DELTA'S IMPACT

The numbers above reflect Missouri Delta's healthcare services and the number of lives Missouri Delta impacted in 2022. This past year, we cared for over 4035 patients in our hospital; treated over 19,800 patients in our Emergency Room; performed 3,335 surgeries and 1,211 endoscopies; processed 389,665 lab tests; completed 47,073 radiology exams; provided 106,802 therapy treatments; completed 171,486 clinic visits and helped bring 450 babies into this world.

As part of our investment in a better tomorrow, we spent \$11.1 million in capital with an operating budget exceeding \$135 million, including a payroll over \$69 million covering 880 employees.

We also gave back to the community over \$3 million in charity care along with lifesaving medications to those without the means to pay. We provided financial support to help patients with transportation needs and will be addressing patients with food insecurities starting in February.

As we continue to move past the pandemic crisis, we are thinking beyond today by transforming our facilities and services to improve our patient's confidence and trust that they will receive the highest quality care within a safe, modern environment at Missouri Delta. Our hospital has prospered for the past 75 years because of the support provided by the community. With your ongoing support, we will continue to pursue our strategies to build a stronger medical center. Our diverse and skilled workforce is equipped to deliver the highest quality healthcare and provide the best experience possible for our patients.

### INVESTING IN A BETTER TOMORROW

# \$135M

## PROVIDING OUR COMMUNITY & PATIENTS THE SAFEST ENVIRONMENT OF CARE RON PRUITT, ENGINEERING AND ENVIRONMENTAL SERVICES DIRECTOR

Missouri Delta made significant capital investments in our plant infrastructure during 2022, using \$5.5 million dollars to upgrade our existing generators, chillers, air handling units, and related electrical circuits which were designed in the early 80s. The Centers for Medicare and Medicaid Services (CMS) now require surgery suites to follow strict standards of temperature, humidity, and room pressure relationships, even during times of power outages. The new generator will provide continuous uninterrupted power to our new Trane HVAC systems that provide the surgical suites proper environmental conditions during events such as electrical storms, ice storms, or city power failures. With our underground fuel stores we can now run 96+ hours before refueling, and indefinitely with continued fuel supplies.

## NEW PROVIDERS + SERVICES



### VESTIBULAR SPECIALIST ZACH SHAW, AuD, CCC-A

Dr. Shaw joined Missouri Delta in the summer of 2022, joining forces with Vestibular Therapist, Chance White, and launching the ReBalance & Dizziness Center. Dr. Shaw is available to perform comprehensive evaluation with data interpretation for patients who are struggling with vestibular deficits, causing symptoms such as dizziness, spinning, feeling off-balance and academic struggles. Chance White, DPT is then able to target his treatment to resolve the annoying or debilitating issues. 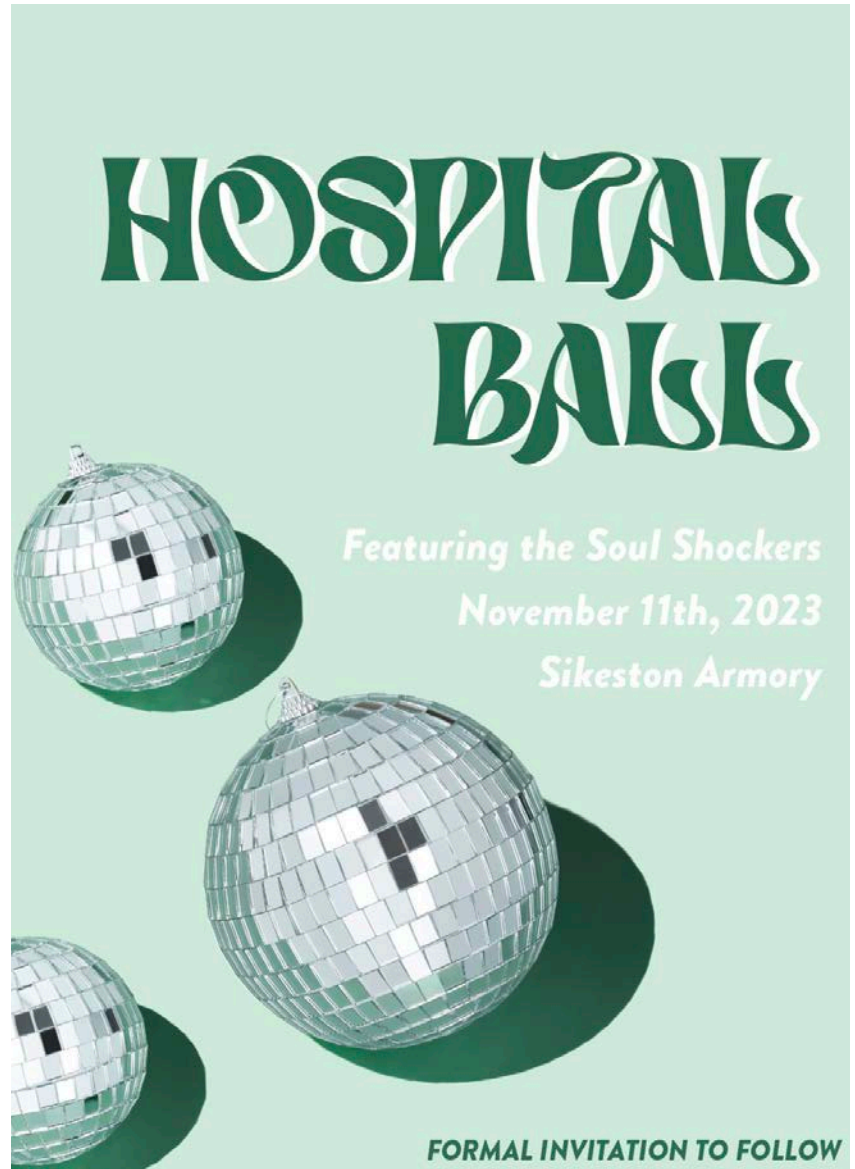
